## **CONDITIONS OF LICENCE FOR OPERATION OF RADIOCOMMUNICATION SERVICE STATION**

---

- 1.0. The licensee is authorised to use the assigned frequency for the period of **THREE (3)** year(s) subject to the payment of appropriate annual fee and may be renewed subject to such terms and conditions as may be specified by the Authority.
- 2.0. Annual licence fees should be remitted at least 14 days before the anniversary of the date of issue.
- 3.0. Three months prior to expiry of the licence period, the Licensee shall apply to the Authority for renewal of the licence.
- 4.0. Annual licence fee delayed for more than thirty (30) days shall be charged interest of fifteen percent (15%) of the outstanding fee for each month of delay.
- 5.0. If any message is received which the licensee is not entitled to receive under the terms of this licence the Licensee shall not make known or allow to be made known its contents, its origin or destination its existence or the fact of its receipt to any person (other than a dully authorized ocer of the Authority or a competent legal tribunal) and shall not reproduce in writing copy or make use of messages or allow same to be reproduced in writing, copied or made use of.
- 6.0. The equipment used on the station shall be of type approved by the Authority and it shall not transmit or receive messages on frequencies other than those authorized.
- 7.0. Only persons dully authorized by the licensee may operate the station.
- 8.0. The call sign assigned in the licence must be transmitted repeatedly during transmission.
- 9.0. The station shall be open to inspection at all reasonable times by dully authorized officers of the Tanzania Communications Regulatory Authority.
- 10.0. The licence is subject to withdrawal or modification at any time by specific notice in writing sent to the licensee. The holder of the licence is bound to comply immediately with any supplement or modification and to bear all costs resulting from any modifications to the technical equipment and from other expenditure, which might become necessary. Any breaches of these conditions will render this licence liable to cancellation.
- 11.0. This licence is not transferable.
- 12.0. If a radio installation is adversely affected by a telecommunication installation serving the public traffic, it is incumbent upon the holder of the licence to have the situation remedied at his own expense in such a way that it is not affected.
- 13.0. Antennas and other parts of the station outside a building or a vehicle must be installed in such a way that they do not endanger the health and safety of members of the public.

- 14.0. The installation of the radio station has to be constantly maintained in proper condition. Any defects must be eliminated immediately.
- 15.0. The radio transmitting apparatus shall be maintained and used so that it does not cause interference with any other radiocommunication station.
- 16.0. The holder of the licence must make alterations to all facilities of the radio installation, including cabling and ground connections at his own expenses, if telecommunication installation carrying public traffic are impeded or endangered by them. The same applies if the erection, modification or removal of the aforementioned telecommunication installation is affected.
- 17.0. The radio equipment installation may only be altered or extended with the approval of the Director General. Any change in the technical and operational characteristics must be communicated to the Authority immediately.
- 18.0. The Director General may at any time after the date of issue, cancel this licence in the event of non compliance with the Regulations or these conditions or if the Director General considers it necessary, without refund of any part of the fee paid.
